#### Welcome

Mr. Chad Davisson, CCSDA Member-at-Large, called the meeting to order and welcomed members.

The Association approved the November 15, 2021 CCSDA meeting minutes.

# Guest Speaker – Amy Worth, Orinda City Council Member and Representative to Regional Transportation

Mr. Mike McGill introduced Ms. Amy Worth, Orinda City Council Member and Regional Transportation Board Representative. Ms. Worth graduated from UC Berkeley.

Ms. Worth provided an overview of how the Regional Transportation Board was created. The Mega Region Legislative Platform was created to shape legislation in order to strengthen regional planning, support new funding and identify projects based on shared priorities of moving rail and people. Urgencies included determining high priorities, speaking with one voice and qualifying for funding from many resources such as federal, state, regional and federal funding to pay for these high dollar projects. Additional priorities include interregional functionality, policy alignments, (i.e., moving people from single occupancy vehicles to carpool or transit), and determining what projects were ready to move forward.

Questions were solicited and answered. Mr. McGill thanked Ms. Worth for her presentation.

# Guest Speaker – Hueling M. Lee, Ed.L.D

Mr. Chad Davisson introduced Dr. Hueling M. Lee, Ed.L.D, Executive Director, Authentic Preparation Today.

Dr. Lee explained that she is operating as education consultant for CSDA. With this collaboration, CSDA intends to continue ensuring public support of member districts and foster public awareness of and value of its member functions and services through collaboration and partnerships with schools. She explained that the state Board of Education approved the State Seal of Civic Engagement for schools to recognize and promote student civic engagement, by encouraging civic learning and informed civic action.

Dr. Lee provided examples of how special districts and schools were able to amplify special districts core services and functions. An overview of the collaboration framework, partnership levers and strategies utilized was provided. More information can be found on the CSDA website under School Outreach and Student Engagement.

Dr. Lee provided an overview of the State Seal of Civic Engagement and explained that it is a systemic lever to more directly address inequity and support students and our communities to re-become "whole" by recognizing how to rebuild and rebalance learning. She reviewed criteria for students to qualify for the State Seal of Civic Engagement. More information may be found at www.civicseal.org/about-us.

Mr. McGill explained that the Executive Committee would like add the position of "Past President" informally to keep Mr. Stan Caldwell on the Executive Committee, This change will be presented formally in a future Bylaws amendment.

The Association approved the nominations for the Executive Committee as presented.

Ms. Susan Morgan, Ironhouse Sanitary District, was nominated as the Contra Costa Countywide Oversight Board Representative. Mr. Steve Smith, East Contra Costa Fire Protection District, was nominated as the alternate representative.

The Association approved the nominations for the Contra Costa Countywide Oversight Board as presented.
