About Independent Special Districts

Independent special districts are public agencies that are created by Local Agency Formation Commissions (LAFCOs) to provide essential services to the public. These districts are locally controlled and highly efficient, and they are designed to be responsive to the needs of the people they serve.

Independent special districts are governed by a legislative body, typically a Board of Directors, whose members are either elected or appointed to fixed terms. The governing body holds regularly scheduled meetings, where citizens are encouraged to voice their concerns, ask questions, and provide feedback on the services they receive.



In Contra Costa County, 42 independent special districts provide a wide range of cost-effective community services. Of these districts, 37 are governed by an elected Board of Directors, while 5 are governed by an appointed Board of Directors.

These services include the provision of drinking and irrigation water, fire protection, flood control, operation of parks and recreational services, conservation of natural resources, vector control, and wastewater collection, treatment, and reuse.

These services are essential to the well-being of the community, and the independent special districts in Contra Costa County are committed to providing them in the most efficient and effective manner possible.

Independent Special Districts are:

- Sanctioned by the State of California government Codes
- Originated as the most economical means of providing public service
- Formed by LAFCOs to provide local services
- Independent, self-governed agencies
- Governed by a Board of Directors
- Responsible directly to the people

In addition to independent districts, there are 30 dependent districts, most of which are governed by the Board of Supervisors.

California Special Districts Association Contra Costa County Chapter

The Contra Costa County Chapter (CCSDA) is affiliated with the state-wide organization of the California Special Districts Association (CSDA). This state association provides education and advocacy services for over 1,000 special districts in California. Local chapters are independent groups of special districts formed to create local networks of special district leaders. Some of these special districts have provided public services for over 85 years.

Chapter Purpose:

To promote the efficient, economical, and responsive public services offered by the independent special districts of Contra Costa County.

Chapter Objectives:

- Support member districts in the provision of services for the people of Contra Costa County.
- Inform the public about the purpose and benefits of local special district government.
- Act as a local forum of member districts for discussion and consideration of special district issues and to establish positions and advocacy on such issues among other governmental agencies, including the Contra Costa Local Agency Formation Commission (LAFCO), county government, cities, and the state of California.
- Facilitate communication among member districts as well as other governmental agencies and organizations.
- Organize workshops, educational seminars, and programs on issues that are mutually beneficial to member districts.
- Make recommendations to the CSDA Board of Directors based on the needs and perspectives of member districts.

The services offered by the Contra Costa County Chapter are designed to foster better communication and cooperation between various levels of local government. The chapter acts as a liaison between multiple agencies and committees, including the Board of Supervisors, LAFCO, Mayors Conference, county planning, cities, and citizen committees. Special district representatives provide valuable input to these agencies, helping to coordinate services and streamline processes across all levels of government.

To ensure the needs of its members are met, the Contra Costa County Chapter holds bi-monthly membership meetings and special meetings when necessary. These meetings serve as a forum for reviewing legislation, sharing information, electing LAFCO representatives, organizing special district responses to local and state programs, and collaborating on projects of mutual benefit.

By bringing together stakeholders from multiple backgrounds and perspectives, the Contra Costa County Chapter helps to create a more cohesive and effective local government.

History of Contra Costa Special Districts Association

In 1989, Chuck Beesley and Bob Berggren initiated the formation of the Contra Costa Special Districts Association (CCSDA) to address the need for an organization of a local association of special districts. The organization was established to tackle issues such as public awareness, property tax growth revenues, and the Special Districts Augmentation Fund (SDAF).

The SDAF was a fund established by the Legislature in 1978 to provide financial assistance to special districts suffering from property tax cuts caused by Proposition 13. However, only Contra Costa and Orange Counties were found to be non-compliant with the fund. The CCSDA sought help from other special district associations and received assistance from the CSDA in developing bylaws and other organizational procedures. The CCSDA later became a fully recognized local chapter of the state-wide CSDA.

History of LAFCo (Local Agency Formation Commission)

Between 1963 and 1985, LAFCo had to administer a complex series of laws and three enabling acts, namely the Knox-Nisbet Act, the Municipal Organization Act (MORGA), and the District Reorganization Act.

Due to confusion regarding the application of these laws, a reform movement was initiated, which led to the creation of the first consolidated LAFCo Act, the Cortese-Knox Local Government Reorganization Act of 1985. In 1997, the Legislature established the Commission on Local Governance in the 21st Century to bring about changes in local governance.

After conducting an extensive statewide survey, the Commission recommended changes to the laws governing LAFCo in its comprehensive report titled "Growth Within Bounds."

The recommendations made by the Commission formed the basis for the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (CKH Act). The CKH Act mandates greater autonomy for LAFCo and further clarifies its purpose and mission.

Contra Costa Local Agency Formation Commission

In 1963, the California Legislature responded to the urban boundary wars and the problem of public finance and service they created by enacting the Local Agency Formation Commissions (LAFCOs). This law established a commission in each county responsible for overseeing most forms of local government boundary change, including incorporation, annexations/detachments, dissolution, incorporation, out-of-agency service, and special district formations.

In the interest of more orderly development, LAFCOs were to act as judges of boundary disputes among governments and communities. Since 1963, numerous changes have been made to the law, culminating in the current Cortese-Knox-Hertzberg Act of 2000, operative January 1, 2001
