The Town of Discovery Bay

The Town of Discovery Bay closed escrow on February 13, 2013 for the purchase of 7.25 acres of land that is now home to the Discovery Bay Community Center. The site was formerly the Discovery Bay Athletic Club, and is located at 1601 Discovery Bay Boulevard, across from the Discovery Bay Shopping Center.

After a short closure, the District reopened the facility on January 2, 2014. The renovation transformed the interior from an athletic club to a multi-use Community Center. The District's Board is still considering options and future uses of the land, including a potential expansion.

The Town of Discovery Bay is currently exploring architecture firms to build a District office for the Town. They are reaching out to you as representatives of our local CSDA chapter for any referrals and/or recommendations from our membership. Could you help with this request?

Fire District Achieves ISO Class 1 Rating

ISO Class 1 with Gold Lettering The San Ramon Valley Fire Protection District is pleased to announce that it has received the Insurance Services Office (ISO) top rating of Class 1, which is the designation it reserves for superior

fire protection programs. The Class 1 rating was based on the ISO's independent analysis of the structural fire suppression delivery system provided to the San Ramon Valley community. According to the ISO, out of the roughly 40,000 fire districts they evaluate across the country, only 411 have earned the Class 1 rating, with the San Ramon Valley Fire Protection District being only 1 of 42 in California to receive the top rating.

The ISO collects information on communities and analyzes the data using its Fire Suppression Rating Schedule, which evaluates four primary categories of Fire Suppression - Fire Department Operations, Emergency Communications, Water Supply, and Community Risk Reduction - intended to measure the effectiveness of protecting homes and other structures, with better fire protection leading to better loss experience.

This plays an important part in the decisions insurers make affecting the premiums for property insurance. The price of property insurance in a community with a high ISO rating is lower than in a community with a poor ISO rating.

Web Accessibility

The U.S. Justice Department (DOJ) has issued web accessibility guidance under the Americans with Disabilities Act (ADA). While many courts have historically held that business and public agency websites are required to be accessible under respective provisions of the ADA, there are no enforceable standards on website accessibility, as there are under Section 508 for federal government websites. Because the DOJ has noted that enforcement of website accessibility is a priority, businesses and public agencies should immediately become familiar with this new guidance and ensure that all components of their websites are in compliance.

The new guidance explains how state and local governments (entities covered by ADA Title II) and businesses open to the public (entities covered by ADA Title III) can make sure their websites are accessible to people with disabilities in compliance with ADA.

As the DOJ has stated, the guidance is intended to provide plain language and user-friendly explanations to ensure it is comprehensible for general readership - not just those with a legal or technical background. The guidance explains that businesses and governments can choose how to make their programs and services offered on their websites accessible, since there is no specific standard. However, it also confirms that the Web Content Accessibility Guidelines (WCAG) and Section 508 standards should still be considered helpful guidance, and entities should continue to reference these standards for the more technical and detailed guidance on website accessibility.

Oakley Science Week comes to ISD

Oakley Science Week came to Ironhouse Sanitary District. The District hosts more than 3,000 school children annually at the center for field trips and education programs. There were crafts, exhibits, and more. Each year the ISD puts together a fun craft themed around the exhibits at the program. This year they created little critters that help clean Ironhorse's recycled water. This activity is fun for all ages. The City of Oakley also provided activities at their table. Diablo Water District was on hand with watersaving tips and more.



CSDA celebrated Special Districts Week while hosting its annual Special Districts Legislative Days in Sacramento on May 17. Over 200 special district officials converged on Sacramento to meet with State Legislators and Capitol Staff. State Insurance Commissioner Ricardo Lara served as opening keynote speaker. The event included State and Federal Legislative briefings, group discussions with Legislators and Capitol staff regarding priority issues facing special districts, and informative sessions including climate adaptation and resilience, infrastructure, cybersecurity and legal briefs.

Park District Receives National Association of County Park and Recreation Officials (NACPRO) Facility Award

East Bay Regional Park District was honored to receive the National Association of County Park and Recreation Officials (NACPRO) Excellence in Park and Recreation Facility Award. The award was given for three Regional Shoreline projects to increase public access, mitigate sea level rise, and restore habitat in 2021: Judge John Sutter, Albany Beach-SF Bay Trail, and Bay Point.



Water District Board Vacancy to be filled by Appointment

During the Board meeting in April, Contra Costa Water District's Board President, Lisa M. Borba, announced that she will resign from the Board effective April 22, 2022, after 12 years representing the community on water issues.

The Contra Costa Water District (District) Board of Directors has decided to fill a vacancy on its Board by appointment, as provided under state law. The vacancy is due to the resignation of Division 1 President Lisa M. Borba. Division 1 includes the District's service area in the cities and communities of Concord, Pacheco, Clyde, Bay Point, and Pittsburg. All applicants must reside within the boundaries of Division 1.

The Division 1 Director's seat will be placed on the ballot for the November 8, 2022 general election. The newly appointed Director will hold the office until the general election results are certified.

SDLF (Special District Leadership Foundation) Recognized Stege Sanitary District with Two Awards

"Our staff is to be commended for their contributions that empower the public with information and facilitate engagement and oversight."

ALAMEDA - CONTRA COSTA TRANSIT DISTRICT

Alameda - Contra Costa Transit District (AC Transit) is advancing towards a zero- emission future through clean transit and green jobs.



The California Air Resources Board (CARB) requires that all public transit agencies transition to a 100 percent zero emission bus fleet by 2040.

AC Transit is the first in the country to complete a Zero Emission Transit Bus Technology Analysis along with development of the AC Transit Clean Corridors Plan and Zero Emissions Bus

The cost of transitioning the AC Transit fleet to zeroemissions is currently estimated to be \$1.1 billion for purchase of zero emission buses and associated infrastructure improvements. This price tag does not include maintenance and operations, nor does it include the workforce development costs associated with this initiative to take the necessary steps to run a 100 percent zero emission fleet.

Celebrating 50 Years of Service



Sept. 11, 2022 marks BART's 50th anniversary serving the people of the Bay Area.

BART began service on September 11, 1972. This golden milestone is also at a time when they are making improvements to the customer experience.

BART is back to full service, and weekend service is better than before for most riders with more trains in service. All BART cars have virus-trapping MERV-14 air filters, and air in cars is replaced and filtered every 70 seconds. BART has a historically high number of safety staff on platforms and onboard trains, and crime is significantly down. Other improvements include mobile payment, station and parking lot lighting upgrades, new escalators unveiled, and the reopening of several underground restrooms.

Wipes

In an effort to address an urgent pollution problem that plagues public wastewater infrastructure, California has passed a law requiring all packaging for diaper wipes, cleaning wipes, cosmetic wipes, and other disposable wipes to prominently display the "Do Not Flush" symbol on packaging.

California's AB 818 was signed into law by Governor Newsom on last October 6, making California the fourth state to require "Do Not Flush" labeling on non-flushable wipes.



National Association Interpretation Sierra Pacific Region Award





National Association for Interpretation is presented to an NAI member who has worked for five or more years in the profession and whose current duties are at least 60 percent supervisory and administrative. They must demonstrate a mastery of interpretive technique, site or program and staff management, and a respected ability to pass these skills on to others.

The National Association for Interpretation (NAI) defines interpretation as a mission-based communication process that forges emotional and intellectual connections between the interests of the audience and the meanings inherent in the resource.

New bike stair channels are in the works for eight stations: 19th Street/Oakland, 12th Street/Oakland, Lake Merritt, Coliseum, Walnut Creek, Embarcadero, Civic Center, and 24th Street Mission. These channels will make it easy to roll your bike up and down stairs. New wayfinding signs will be installed at the stations to guide you to entrances and exits with the channels. 19th Street Station will be the first station to get the bike channels and we plan to do extensive user experience testing to ensure the design works for larger bikes before we move forward with the other stations.

Ironhouse Sanitary District Evaluates Highest and Best Uses for Jersey Island

The Ironhouse Sanitary District owns a 3600-acre delta island, Jersey Island. The District purchased this island in the early 1990s and, for decades, used the island for land application of treated wastewater. Over the years, the District developed agricultural operations on Jersey Island including a cattle operation with over 2500 head of cattle and growing hay and other crops on 450 acres.

In 2012, the District completed construction of a new, state of the art water recycling facility which utilizes advanced micro-filtration and UV disinfection processes. As a result of the new plant, the District obtained a permit to discharge highly treated water into the San Joaquin River and provide recycled water to residents and businesses. These improvements meant that land application of the treated water on Jersey Island was no longer needed.

As a reclaimed delta island, Jersey Island has 16 miles of levees that require ongoing continual maintenance. The cost of maintaining the levees averages around \$2M per year. Without the regulatory need to use the island for land application of treated water, the District embarked on identifying different uses that would offset the costs of maintaining it, reducing operational costs and finding potential new uses and revenues to best manage our rates to our customers.

Changing Operations:

The District decided to get out of the cattle business. In early 2022, the District entered into a 5-year lease agreement with a private cattle rancher, Auburn Ravine Ranch. This lease brings in an additional revenue of over \$800,000 per year! During 2021 and early 2022, the District sold all of our cattle strategically to get the highest value. Liquidation of our cattle inventory yielded nearly \$3M for the District's reserves, and significantly reduced operational costs.

New Use Evaluation:

In the long-term, the District partnered with a private firm, Montezuma Water, to look at the feasibility of developing innovative new uses for Jersey Island. Potential new uses include the possibility of recreation. conservation, energy production, commercial and even residential developments. Montezuma is currently evaluating regulatory, zoning and environmental requirements associated with these potential new uses.
