January 27, 2020 Annual Meeting

At the January 27, 2020 meeting (our annual business meeting) we will have the Election of Officers - President, Vice President and Member at Large.

Governor Vetos Bills

October 13th marked the final day for Governor Gavin Newsom to sign or veto legislation passed by the Legislature in 2019. For the year, there were 3,033 bills introduced by the California State Legislature and reviewed by CSDA in 2019. CSDA actively tracked 787 of those bills. Of those, CSDA supported 67, opposed 63, and "watched" the remainder. Many of the bills signed into law will affect how special districts serve their communities in 2020 and beyond.

In his final action of the 2019 legislative season, the Governor vetoed a number of bills that would significantly increase costs outside of the state's regular budget process. In total, Governor Newsom vetoed bills this year costing \$1.2 billion, increasing to \$3 billion annually at full implementation. He also took action on a number of other bills.

Public Agency Email Retention Requirements Vetoed by Governor

Governor Newsom vetoed Assembly Bill 1184 by Assembly Member Todd Gloria (D-San Diego). If signed, the bill would have required public agencies to keep all emails sent and received by the agencies for at least two years before they could be deleted or destroyed.

CSDA led the opposition coalition efforts to stop the bill's passage and with the help of many of our members sending in veto request letters CSDA was successful in having the bill vetoed. In the Governor's veto message, he wrote that "[t]his bill does not strike the appropriate balance between the benefits of greater transparency through the public's access to public records, and the burdens of a dramatic increase in records-retention requirements, including associated personnel and data-management costs to taxpayers."

East Contra Costa Fire Protection District

Congratulations to the e East Contra Costa Fire Protection District wh received the District Transparency Certificate of Excellence by the Special District Leadership Foundation (SDLF) in recognition of its outstanding efforts to promote transparency and good governance.

"This award is a testament to East Contra Costa Fire Protection District's commitment to open government," said, Fire Chief Brian Helmick. "The entire district staff is to be commended for their contributions that empower the public with information and facilitate engagement and oversight."

To receive the award, a special district must demonstrate the completion of essential governance transparency requirements, including conducting ethics training for all board members, properly conducting open and public meetings, and filing financial transactions and compensation reports to the State Controller in a timely manner.

"I am ecstatic to hear that we have worked through the process, to acquire this certificate of excellence," said, President Brian Oftedal. "It is extremely important to me, that we are accessible, promote transparency and maintain public trust." The application process to obtain this certificate is not easy. There is an extensive list of requirements. "I am thrilled that we are now able to showcase East Contra Costa Fire Protection District's commitment to transparency."

SDLF is an independent, non-profit organization formed to promote good governance and best practices among California's special districts through certification, accreditation, and other recognition programs.

Special districts are independent public agencies that deliver core local services to communities, such as water, wastewater treatment, fire protection, parks and recreation, healthcare, sanitation,

mosquito abatement, ports, libraries, public cemeteries and more. Districts are established by voters and their funding is approved by voters to meet specific needs through focused service. They can be specially molded to serve large regions or small neighborhoods depending on the need.

Our July meeting will be a joint meeting with Alameda County chapter of Special Districts.

The Board of Supervisors established the Treasury Oversight Committee on January 1, 1996 with the purpose to:

- Review the county's investment policy,

- Report on the pool's performance to the board of supervisors, and
- Ensure an annual audit is conducted to determine the County Treasurer's compliance with Government Code Section 27130-27137

BARTFare Increase Update

A 5.4% inflation-based fare increase will take effect on January 1, 2020 as part of a program that has been in place since 2003 to raise fares every other year to keep up with the cost of inflation. For a short trip like Downtown Berkeley to 19th St./Oakland, the Clipper fare will increase by 10 cents, and a longer trip like Antioch to Montgomery will increase by 40 cents.

Contra Costa LAFCO Commissioners win award

On October 30th, Contra Costa LAFCO Commissioners were named "Most Effective Commission" in California at the annual California Association of Local Agency Formation Commissions (CALAFCO) Conference.



Contra Costa LAFCO Commissioners were recognized for their diligence and leadership. Their endeavors to promote healthy and sustainable local agencies through analysis and assistance and intervene when needed to restructure or dissolve struggling agencies supports the goal of LAFCOs to promote efficient service delivery which is essential to the fiscal, economic and social wellbeing of Contra Costa County and California. Since 2010, Contra Costa LAFCO Commissioners have assisted three special districts to improve their operations and transparency, encouraged one district to revise its governance structure, reorganized one special district, and dissolved four special districts due to lack of or poor performance.

This is the latest of many State awards received by Contra Costa LAFCO. Other Contra Costa awards include 2016 Outstanding Commissioner - Don Tatzin, 2013 Outstanding LAFCO Professional - Lou Ann Texeira, 2013 Outstanding LAFCO Clerk - Kate Sibley, 2011 - Government Leadership Award - Central Contra Costa Sanitary District, 2007 - Lifetime Achievement Award - John T. Knox, 2007 and several others from earlier years. Contra Costa LAFCO is a State regulatory commission responsible for encouraging the orderly formation of local government agencies, preserving agricultural and open space lands, and discouraging urban sprawl. LAFCO is governed by a seven-member commission comprised of two County Supervisors, two City Council Members, two Special District Board Members, and one Public Member, plus one alternate member in each category. CALAFCO is a statewide organization dedicated to assisting member LAFCOs and serves as a resource to the California Legislature and other government agencies and organizations.

Historical Society Project Update

At prior Contra Costa Special Districts Association meetings the membership voted to proceed with the project of -creating a curriculum-friendly history of the special districts in Contra Costa County.

The goal is to create a curriculum friendly history of the independent special districts that could ultimately be used by school teachers. Work with the Contra Costa County Historical Society which would produce a document of 2 to 3 pages per District (including maps) that would reflect the description and history of each District in Contra Costa County in a way that could best be used by a teacher to introduce the various districts to his or her students. It is expected that project will soon be completed. It will then be available on the chapter's website.

❖ *A voice in organizational decision making*


Our members have the right to meet and elect all members of the governing board of the organization and to set policies (Executive staff election is held every two years).


