Corona Virus Challenges

This past year has brought unprecedented challenges to special districts, especially for those who were struggling before the coronavirus pandemic began. But today, even with the hopes brought by the vaccines, the situation for far too many districts remains very challenging.

Much has been written about the long-term effects of the COVID-19 pandemic, the shutdowns it has caused, and the effects on state and local government budgets and revenues. Special districts are government entities that are uniquely vulnerable but have not received the same level of attention. These include parks, fire, sanitary, water, entities responsible for operating, and are reliant on revenues from, property taxes and fees have been severely affected by the pandemic.

The pandemic's impact on how special districts deliver services were just as sweeping-and likely just as permanent. Districts moved everything from public meetings, to client intake processes, recreational programs onto digital platforms.

In many cases, these new digital offerings didn't just respond to the need for social distancing, they sometimes increased citizen engagement. District leaders often saw greater attendance at public board meetings, community planning sessions, rate increases proposals, and other

board business, the enthusiastic reception means once digital services are turned on, it's unlikely they'll be turned off.

Legislative Session

It's a new year, a new legislative session, and the same COVID-19 with many of the top issues of2020 back on the agenda, including wildfires, climate, housing, and homelessness just to name a few. In anticipation of the work ahead, legislative leaders established several new committees, including the Joint Committee on Emergency Management.

On January 8, Governor Gavin Newsom unveil his 2021-22 State Budget Proposal outlining his funding priorities for the year and setting in motion the Legislature's budget process.

No District Budget Limits for Education Scholarships



Ironhouse Sanitary District opened its Recycled Water Fill Station

While most of California is experiencing mild drought conditions, State officials have reported that Contra Costa County is experiencing severe drought conditions. To help residents reduce the water use in gardens, landscaping, and lawns, Ironhouse Sanitary District (ISD) has decided to open its Residential Recycled Water Fill Station early this year. The Fill Station is now open.

DSRSD's Levi Fuller, who retired on June 8, made a mark on the industry

Levi Fuller presented how the district manages biosolids
(land application) on May 27 as part of a national
training webinar on behalf of the Environmental

Levi retired from DSRSD on June 8, 2021–just over 21 years after joining the District in January 2000. With a background in desalination on an aircraft carrier while in the US Navy, Levi worked for the City of Pinole's wastewater treatment plant as plant supervisor before joining DSRSD.

While he managed wastewater and recycled water treatment at DSRSD's Regional Wastewater Treatment Facility, Levi's favorite project was encouraging others to join the wastewater industry. He served on the Executive Committee for the Bay Area Consortium for Water and Wastewater Education (BACWWE) and was a regular instructor for the college-level Wastewater Treatment I course. He estimates about 75% of the wastewater treatment plants in the Bay Area have one of his former students on staff.



Levi Fuller, Wastewater Treatment Plant Operations Supervisor for Dublin San Ramon Services District. "It's a neat feeling to have made that contribution to the industry," Levi said.

Levi also served as Chair for the Staff Preparedness Committee for Baywork (a consortium of utilities working to ensure a reliable workforce), has served on the Operations & Maintenance Committee for BACWA (Bay Area Clean Water Agencies), and has been a member of the California Water Environment Association, the California Association of Sanitation Agencies, and the Water Environment Federation (WEF). In 2019, Levi spoke at a WEF conference and at a statewide Association of California Water Agencies conference to promote recruitment of more underrepresented populations to the field.

Levi was recently quoted in a June 2 USA Today article about infrastructure jobs, saying, "Despite the fact that people have water in their house and flush the toilet every day, not very many people think about water or wastewater as a career. We have to market these jobs and make sure high school kids who are smart consider it."

How To Spot a Fake Email Message?

Fraudulent email messages designed to cheat, steal, and defraud the recipient out of their credentials, money and sensitive identification continue to plague computer users throughout the United States and world!

Thieves leverage both nationally recognized brands, as well as, regional and local brands to achieve the same goal, steal your money! The criminals use these brands in phishing schemes to target users.

What is a phishing scheme? We see it as a fraudulent practice of sending emails purporting to be from a reputable company, in order to induce individuals to reveal personal information, such as passwords and credit card numbers.

Once hackers have information like a username and password, for example, they will use it to further the spread of their scams and steal from you. In the worst cases they will clean out financial accounts, steal sensitive photos, or rob the victim of crypto currency. While these types of crimes are quick and painful, there are lingering impacts to your life because the hackers now have access to the restricted part of your life and often trade or sell your information on the dark web, to other hackers.

In other examples you might get an unexpected invoice

It happens to all of us, we receive an email from trusted brands like Amazon, USPS, FedEx, Norton anti-virus, Godaddy, and Microsoft, only these are not the actual senders of the email. The invoices are totally fraudulent. They can even include toll free numbers that lead to overseas call centers that will take a payment from you for the fake invoice.

How to quickly spot a fake

If you know where to look, the fake emails are easy to spot. Most often in the header of the email, where the "from name" is located, an email address will NOT match the supposed company sending the message. Read that Again! The "from name" email address will NOT match the supposed company sending the message. Often you will see a name in the "from name" that is close to a real company and an email address that is completely inaccurate.

The extension will be from a free email hosting account like @gmail.com, @outlook.com, @hotmail.com, or sometimes it will be from a random domain that has been compromised, something like 'xyzlook.org'. That is your signal to immediately report as spam and delete the message.

DO NOT CLICK ON ANY LINKS IN THE EMAIL or call the number. The email can infect your computer or cost you money. At the very least it can notify the hackers that you are a person who will engage with their scam attempts and they will triple down on their efforts.

SUCCESS OF COCO SAN SUSTAINABLE FARM

I'm an ardent supporter of this Farm; volunteering to work on site on Saturday mornings and many Wednesday mornings, I also donate and help fund raise.

My initial interest was to showcase the value of the recycled water that Central San produces; now that interest has grown to embrace all the foci of Aglantis, the non-profit running the Farm. These foci are: 1. Food Equity and Public Health, 2. Environment, 3. Education and 4 Economic Development and Job Training. These align with Central San's Mission of Protecting Public Health and the Environment.

Aglantis leased, for \$1/year, about a 15 acres of Central San buffer land. The site was a barren, sterile area. Aglantis, using donated wood chips and "organic" horse manure, produced "soil".

The 2020 COVID-19 pandemic initially adversely impacted farming efforts, as all other volunteers stayed sheltered, but soon created positive impacts: starter plants were donated by DVC Horticulture, Master Gardeners and others that were not able to hold their plant sales and many, both old and new volunteers joined a few months later where outdoor work with great social distancing was possible.

Aglantis wrote in their annual report to Central San "Our years of building soil fertility paid off with productivity many times greater than normal for an urban farm. We grew a wide variety of crops including: zucchini, winter squash, tomatoes, potatoes, kale, lettuce, pumpkins, chard, peppers, eggplant, melons, cabbage, broccoli, cauliflower, leeks, green onions, parsley, sage, thyme, dill, basil, rosemary and other herbs. We were excited to see that our crops flourished in our amended soil and grew abundantly in recycled water. The quality of this produce was very good."



In 2020 over 25,000 pounds of fresh produce were donated to the Food Bank and White Pony Express, both 501c3 food distributors. This was from only a half-acre of land.



In 2019 a hoop greenhouse (for plant propagation) was erected but not covered since so many starter plants were donated in spring 2020. This year the plastic roof was installed and plants started. The irrigation system is being expanded and ultimately 100,000s pounds will be annually donated.

Central San's recycled water, California Title 22 approved for agriculture use, is a major reason for the This water is full of nitrogen, potassium, phosphorous and micronutrients so no added fertilizer is needed.

National Special Districts Coalition (NSDC) Updates

The National Special Districts Coalition (NSDC) adopted its first-ever federal legislative platform, providing a guide for special districts' national advocacy.

The document serves as the foundation for NSDC's legislative priorities and outlines key policies impacting the nation's more than 30,000 special districts across the country. Special districts, or special purpose units of government, are local governments created by the people of a community, as authorized under state statutes, to deliver public services that other units of government do not otherwise provide.

Overarching components of the platform include securing a "special district" definition in federal law; ensuring all special districts have equitable access to state and local pandemic assistance; supporting climate adaptation and community resiliency policies benefitting special districts; developing sound solutions to harden infrastructure and safeguard funding mechanisms for infrastructure projects; pressing for easier access to federal funding opportunities; fostering development and enrichment of disadvantaged communities; and ensuring special districts' concerns are considered in regulatory processes.

Significant activity continues around the NSDC. Some highlights in May included:

- Hosted an NSDC webinar on May 20 to provide details to special districts about the American Rescue Plan (ARP) Act's pandemic relief resources, including the recent U.S. Department of Treasury guidance on the \$350 billion State and Local Fiscal Recovery Funds, which special districts may access by transfer from states, counites, or cities. Nearly 600 participants attended throughout the nation.
- Sent two congressional letters urging the state to share ARP funds with special districts
- Assisted in developing and coordinating a coalition letter signed by 15 congress members and sent to the Governor, Pro Tem, and Speaker.
- Coordinated 2 press releases from electret's highlighting the above letter as well as the need.
- NSDC signed on to a letter and coalition urging for \$30 billion in federal infrastructure funding (over the course of a decade) to investment in necessary forest management/health and protection of critical watersheds.
- Developed system to track NSDC priority legislation.
- Further developed NSDC membership categories to be launched in the coming months.

 Sent formal invite letters to the Wyoming and South Carolina special district associations to join the NSDC.

Historical Society Project Update

CSDA Urges Supreme Court to Provide Special Districts Relief from At-Large **Election System Litigation**

A case currently pending in the Supreme Court of California concerning the California Voting Rights Act (CVRA) may have wide-ranging impact on any special district that elects its Board of Directors in an at-large election system.

On June 15 the California Special Districts Association (CSDA) joined the League of California Cities ("Cal Cities") to file an amicus brief to the Supreme Court in support of Santa Monica, urging the court to consider the practical concerns guiding special districts' decision to switch to by-district elections, and seeking clarity in how the CVRA is applied to legitimate, nondiscriminatory at-large election systems.

CSDA will continue to monitor this case and inform our members when an opinion is issued in the matter.

As California businesses begin the process of reopening and expanding capacity, the Contra Costa Mosquito & Vector Control District (district) is happy to announce the district is once again open to the public. The district is located at 155 Mason Circle, Concord, CA 94520, Office hours are 8:00 a.m. - 4:30 p.m. Monday - Friday.

In 2020, the district received 131 requests for Mosquitofish Service. Halfway through this year, the district has already received 133 requests. According to District Operations Supervisor David Wexler, the service has not only proven to be popular with residents, but it is also beneficial when it comes to the district's efforts to reduce the risk of mosquito-borne disease.

East Ba Regional Park District Approves Lease with Dig Deep Farms for Organic Heritage Farming at Ardenwood Historic Farm

On Tuesday, May 18, 2021, the East Bay Regional Park District Board of Directors unanimously approved a 5-year lease with Dig Deep Farms to continue organic heritage farming at the Park District's 205-acre Ardenwood Historic Farm in Fremont. Dig Deep Farms is a nonprofit enterprise of the Alameda County Deputy Sheriffs' Activities League. Ardenwood Historic Farms has been operation by J.E. Perry Farms since the mid-1980s. J.E. Perry Farms ceased operations in 2020 due to retirement.



Ardenwood Historic Farms is a working farm that provides a journey back to the 1850s Patterson Ranch - a prosperous, 19th-century country estate with a beautiful Victorian mansion and elaborate Victorian Gardens. The farm still grows the same kind of produce grown in the region over the last 100 years, utilizing historical agricultural practices from the 1870s to present. Park District interpretive staff and volunteers guide guests through the Victorian house, demonstrate historical farming practices and chores, and describe what life was like in the early 1900s. Ardenwood receives over 120,000 visitors annually.

"The lease is an important step to continue the historical farming at Ardenwood and provide the public, especially youngsters, an opportunity to learn about the history of science and agriculture and what life was like in the late 1800s and early 1900s," said Ayn Wieskamp, who represents Fremont on the East Bay Regional Park District Board of Directors. "The farming operation provides the mechanical labor that produces all of the traditional heritage fruits and vegetables, all of which helps educate visitors about the history of agriculture in the region."

Ardenwood Historic Farm is owned by the City of Fremont and operated by the Park District on a long-term

management lease. Established in the 1996 Ardenwood Business Plan, the purpose of Ardenwood Historic Farm is to preserve agricultural land, provide an opportunity to demonstrate historical and current farming practices, and offer educational, cultural, and recreational opportunities to the community related to historical and heritage farming and horticultural practices. The Park District's 2005 Land Use Plan for Ardenwood Historic Farm requires preservation of the land through agricultural use.

"I would like to first express my thanks to the members of the East Bay Regional Park District Board of Directors for awarding the lease agreement to Dig Deep Farms to operate Ardenwood Farms," said Alameda County Supervisor Richard Valle. "Alameda County has invested in and partnered with Dig Deep Farms and other stakeholders to strengthen the local food system, increase food security, and provide training and employment to disadvantaged residents by building local capacity to harvest, process, and distribute fresh and sustainable specialty crops."

"Dig Deep Farms uses traditional farming methods and applies years of Certified Organic Farming experience to work harmoniously with the land, minimizing waste and maximizing nutrient rich soil and produce," added Valle.

Dig Deep Farms is expected to begin site preparations this June, with the first crop harvest in late summer/early fall. Dig Deep Farms exists to create jobs and healthy food through a network of food businesses where access to both has historically been limited.

Alamo-Lafayette Cemetery District



The Alamo-Lafayette Cemetery District was formed as an independent California Special District in 1937. They consist of two pioneer cemeteries, one located in Lafayette and the other in Danville. The Lafayette Cemetery's first burial was in 1854 and the Alamo Cemetery's first burial was in 1856.

The Alamo and Lafayette cemeteries have some of the oldest pioneer families and local historical figures buried within the grounds. Below, we have self-guided tours that guide you through the cemeteries. Each self-guided tour contains a map to help you find your way and historical information on some of our most prominent local figures.

The new park name also recognizes the significant contributions of Thurgood Marshall in advocating for the Port Chicago 50 and desegregation of the U.S. military.

Are Public Agency Remote Meetings Coming to an End?

With the planned reopening of the State on June 15, many public agencies have been asking if the Governor plans to rescind his Executive Orders (N-25-20 and N-29-20) that suspend certain provisions of the Brown Act and allow public agencies to hold teleconferenced or remote meetings.

The Governor's office has announced that Executive Order N-29-20, which relaxed some Brown Act requirements to facilitate virtual meetings, will temporarily remain in effect beyond June 15, 2021. Governor Newsom has stated that on June 15 he intends to terminate California's "Blueprint for a Safer Economy" to permit a full re-opening of the State.

In response to questions from local government groups, Cabinet Secretary Ana Matosantos issued a letter confirming the Governor's desire to achieve "an orderly return to the ordinary conduct of public meetings of state and local agencies and boards." The letter declares that the Governor plans on terminating COVID-19 executive orders "at the earliest possible date at which conditions warrant...." But Secretary Matosantos promised that the Governor's office will provide advance notice of the rescission of Executive Order N-29-20 in time for agencies and boards to meet "statutory and logistical requirements." So, as of now, it is unclear for how long this Executive Order will remain in effect after June 15.

Executive Order N-29-20 waived certain provisions of the Brown Act, including requirements that meetings be conducted in physical locations, and that public agencies identify the locations from which board members participate. It has provided the basis for most virtual public meetings during the pandemic.

Additionally, the Governor could rescind the Executive Orders outright and immediately require public agencies hold in-person public meetings of their governing boards. This would create significant challenges for agencies that have already scheduled remote meetings and for those agencies that are not prepared to hold socially-distanced in-person meetings.

Mt View Sanitary District Billboard

Every May and September the Mt. View Sanitary District has a billboard up to celebrate Wetlands Month or Pollution Prevention. This was the billboard for May 2021. They often partner with Contra Costa Central Sanitary District.



Late Census: Redistricting

Many special districts have generally defaulted to a longstanding statute that calls for new maps to be adopted at least 180 days prior to a general election.

SB 594 (Glazer) Local Redistricting - an urgency bill would mitigate issues surrounding the potential delay in the release of data from the US Census and the effect of that delay on local redistricting. The measure will call for special districts to adopt their post census re-districting maps prior to 180 days before a general election.

Due to the COVID-19 pandemic, the U.S. Census Bureau was delayed in completing its constitutional mandate to provide census data. This will cause the release of the official census data to be delayed by as much as six months to the states and local governments.

Without this data, state and local electoral divisions cannot be adjusted to reflect the new population changes or comply with various state and federal voting laws.

Census Bureau Definition of Special District Governments

The Census Bureau defines special district governments as: "All organized local entities (other than counties, municipalities, townships, or school districts) authorized by state law to provide only one or a limited number of designated functions, and with sufficient administrative and fiscal autonomy to qualify as separate governments; known by a variety of titles, including districts, authorities, boards, and commissions." (Census Bureau Federal State and Local Governments Definitions)

BART Service Increased June 7th

On Monday June 7th, BART doubled the number of 15minute frequencies on weekdays and now offers more trips on Saturdays.

While trips have been added to increase service, BART hours remain 5am-9pm on weekdays and 8am-9pm on weekends. Midnight service Monday-Saturday will return on August 30th BART will add 26 additional trips to the Monday-Friday schedule. The additional trips will serve the busiest lines: Yellow (Antioch-SFO), Green (Berryessa-Daly City), and Red (Richmond-Millbrae + SFO). Most of the added trips will be during the morning and evening commute periods where car occupancy data has demonstrated a need to increase service to help avoid crowding.

Saturdays will get more frequent service with the addition of 16 trips added throughout the day. Saturday ridership has recovered at a faster rate than weekday ridership with Saturday, May 29, 2021, posting the highest Saturday ridership since the pandemic.

Here are some Cybersecurity Tips For Special Districts and home computer users:

- 1. Set up IT security audits at least once a year with IT solutions experts. Even if you have an IT department, it's always best to have a second professional opinion.
- 2. Update your software and operating systems. (It is sometimes best to consult with your IT solutions provider first, as they stay up-to-date on issues related to certain software updates not properly integrating with certain devices.)
- 3. Passwords -
- A) Create strong passwords with upper case letters, numbers and symbols
- B) Use different passwords for different logins
- C) Make login attempts have a limit
- D) If possible, use double authentication logins (for example, you login and then are sent an SMS pin code to enter)
- E) Find the best method of storing your passwords safely (e.g., online password managers and pocket-sized password vaults)
- 4. Secure your Wi-Fi networks from unauthorized access -
- A) Encrypt your access point
- B) Scan your network on a regular basis
- C) Hide your SSID
- D) Disable access from outside of the network
- 5. Back up your data through an external hard drive and the cloud
- 6. Always use anti-malware on company devices. We highly recommend ESET (though it is not available for iPads or iPhones—if your employees use those devices for your company, please contact an IT consultant so we can find the best anti-malware solution for you)
- 7. E-waste old hard drives so old data cannot be accessed
- 8. Utilize firewalls in your company, whether it's from software providers or hardware-based firewalls
- 9. Disable file and media sharing if it's not needed
- 10. Enable HTTPs on your website with an SSL certificate
